## CONTRACT AND BILL OF SALE

**This Agreement is Made for the benefit and protection of the buyer, as well as the seller.**

Seller warrants, to the best of their knowledge that the above described puppy is in good health and of pet quality at the time buyer assumes ownership. Reasonable care has been exercised to prevent or eliminate parasites and / or skin problems.

Buyer should have a licensed veterinarian examine this puppy within 72 hours ( not including Sundays or Holidays) of purchase. If a licensed veterinarian declares this puppy in unacceptable health and the puppy and pedigree and returned to seller within 24 hours of the exam, seller will gladly refund the purchase price or exchange for another similar puppy of one is available at that time. A written statement from the veterinarian is required. Intestinal parasites, Coccidiosis, and Hypoglycemia are not covered under this 72-hour warranty.

If within twelve months from the date of birth, a licensed veterinarian diagnoses this puppy with a genetic health defect that causes death, or is seriously debilitation or life threatening, puppy will be replaced with another puppy of equal value (as per original purchase price) as soon as one is available. There are no cash refunds or veterinarian fees refunded. In order to exercise such replacement option, Buyer must submit, from a licensed veterinarian, either a medical report stating that a severe health problem attributed to a genetic defect exists, or proof of death resulting from a genetic problem. Should a death occur due to an unknown cause, a licensed veterinarian must perform an autopsy, and a copy of the report forwarded to seller before determining if a replacement is to be made. All expenses are the Buyer's responsibility including the shipping of a replacement puppy. Inability to breed or perform in shows is not covered under this 12 month warranty. The new owners take full responsibility for their new puppy from the moment of purchase. Wagg-n-tails is not reliable for any vet bills, medical expenses or any damages, injuries or illness caused by the puppy or from such things as ear mites, worms or other parasites, this puppy is sold as a pet. No Refunds will be given unless pup has a fatal genetic issue documented by your vet and a second opinion of the issue is also verified by our vet. Should this pet not fit with the family, the new pet owner is responsible for placing the pet into a new home Color, weight, temperament, etc. cannot be guaranteed in a young puppy. However, seller can make an educated guess based upon the parent's physical characteristics and personality, as well as previous litters.
